Title: Steuben County Community Services Mobile Mental Health Therapist (Full-Time) 37.5 to 40 Hours/Week (County Partnership Position)

Position Summary:

The Mobile Mental Health Therapist position is contracted through Family Service Society, Inc. and serves in the role of a therapist for the Steuben County Community Mental Health Center (SCCMHC). The Mobile Mental Health Therapist is responsible for crisis intervention services in the office and in the community. The Mobile Mental Therapist will interface with local providers and provide linkages to other services as needed.

Essential Responsibilities or Functions of the Position:

1. Responsible for provision of crisis intervention services in the office and in the community.
2. Develops and maintains accurate and timely client-specific records, reports, billing, treatment plans and progress notes according to all oversight agencies.
3. Responsible for making referrals as deemed appropriate.
4. Provides on-call coverage.
5. Participates in training, supervision and multidisciplinary team meetings.
6. Carries out all other duties and/or responsibilities as assigned by the Supervisor.

Education and Experience Requirements:

Master's degree in social work or in Mental Health Counseling from a program approved by NYS Education Department is required, with a NYSED professional license as a LMSW, LCSW, or LMHC or LMFT, Ph.D, or PsyD. Limited permit holders are welcome to apply. Experience in working with individuals in crisis, working within a multidisciplinary team and a working knowledge and understanding of mental health diagnoses is preferred.

Knowledge, Skills and Abilities:

The Mobile Mental Health Therapist must have skill in gathering, interpreting, and reporting information in addition to skills in written and verbal communication. Ability to make work plans and follow through on those plans independently and the ability to identify areas in need of improvement and recommend solutions is a must. The Mobile Mental Health Therapist will have good time management and organizational skills. Ability to liaison with external agencies is a must. Proficiency in computer skills is needed. The Mobile Mental Health Therapist must also have the ability to exercise initiative, problem-solving, decision-making. Sound clinical judgment and working

knowledge of the DSM-V along with ICD-10 is required. Must maintain a valid driver's license and driving record that meets the agency's insurability guidelines to operate agency owned vehicles.

Typical Working Conditions:

- Exposure category #1 (OSHA Blood borne Pathogens).
- Normal classroom and/or office environment.

Typical Physical Demands:

Requires sitting, some bending, stooping and stretching. Requires eye-hand coordination and manual dexterity sufficient to operate a computer keyboard, copier, telephone, calculator, and other office equipment. Requires normal range of hearing and eyesight to record, prepare, and communicate appropriate reports.

Background Check:

Must meet the requirements of the School Age Care, Day Care, and/or Mental Health Regulations regarding a State Central Register Clearance regarding history of abuse/maltreatment of children.
